BLOCK PARTIES ARE NOT FOR PRIVATE PARTIES!

Anyone requesting for street closure for a Block Party must provide the following:

- A petition with signatures containing the names, phone numbers and addresses of your neighbors on both sides of the street
- A minimum of 65% of the residents' signatures must be provided.
- Follow the procedures on the permit 9:00 AM to 10:00 PM.
- Alcoholic beverages are not permitted on the street, or the event will be shut down.
- Prior complaints may result in the denial of your request.
- You must provide a program of activities during your Block Party.
- After the Block Party, the street and block must be cleaned.
- Police patrol will be requested at each event.
- Failure to comply with the above may void your application process.
